Our firm is Paratus Financial, Inc. and we are registered as an investment adviser with the U.S. Securities and Exchange Commission. As an investment adviser we provide advisory services. Brokerage and investment advisory services and fees differ, and it is important for you to understand these differences. Item 2 – What Investment Services and Advice Can You Provide?

Investment Management Services

Clients: We offer services to individuals, high net worth individuals, trusts, estates, retirement plans, and foundations.

Accounts: We service Individual, Joint, Traditional IRA, Roth IRA, UGMA, 529, 401(k), Partnership, Corporation, Trust, and Foundation accounts.

Investments: We use mutual funds, exchange traded funds, separately managed accounts, and bonds to construct portfolios.

Monitoring: We monitor appropriateness of securities in accounts on a quarterly basis. We also meet with you at least annually depending on your needs and your individual contract.

Investment Authority: We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives with your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing.

Limited Investment Offerings: We do not make available or offer advice with respect to proprietary products or a limited menu of products or types of investments.

Account Minimums & Other Requirements: We do not require an account or relationship size minimum in order for you to open/maintain an account or establish a relationship.

Item 3.A – What Fees Will I Pay?

Investment Management Services

Advisory Fee: Paratus Financial, Inc. does not impose asset-based fees. All fees paid to Paratus Financial, Inc are agreed upon each year in your annual contract.

Conflicts of Interest: We recommend securities that have additional associated fees. You could purchase these securities directly.

Funds we recommend may have different classes with different fee structures.

Our advisors are compensated based on the amount of revenue you pay Paratus Financial, Inc. The total fee you pay the firm is disclosed in your annual contract.

Other Fees & Costs: In addition to our fees, you will also be responsible for custodian fees, account maintenance fees, fees related to mutual funds, and other transactional fees.

Item 3.B – What Are Your Legal Obligations to Me When Acting as My Investment Adviser? How Else Does Your Firm Make Money and What Conflicts of Interest Do You Have?

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours.

Our recommended investments have additional associated fees. Funds may have different share classes with varying fee structures. Our advisors are compensated based upon the revenue they generate to the firm.
